How many MW of solar projects did Croatia tender?

The Croatian authorities initially reviewed 144 projects totaling 713 MW for the auction. The tender was carried out in two phases. One awarded market premiums for projects with installed capacities of more than 1 MW each, including 350 MW of solar, 60 MW of wind, and 7.25 MW of hydropower.

Did Croatia get the green light for IE-energy's massive energy storage project?

Croatia got the green light from Brusselsfor a EUR 19.8 million grant to IE-Energy for a massive energy storage project.

When was the first solar auction in Croatia?

The first auction for large-scale projects in Croatia took place in 2022to procure 638 MW of new capacity. However, it only attracted tepid interest, with premiums awarded to just 107 MW of projects. The regulator offered a 300 MW quota for solar plants, but only four bids were accepted, for a total capacity of 8 MW.

How much ie-energy aid will Croatia get?

The European Commission has approved EUR19.8 million(US\$20.1 million) in state aid from the government of Croatia to energy storage operator IE-Energy for a series of grid-connected projects. The aid will be a direct grant to IE-Energy and will cover approximately 30% of capital expenditures for a series of grid-scale battery energy storage systems.

How much does solar cost in Croatia?

The maximum reference values of market premiums for solar were EUR0.82/kWhand EUR0.75/kWh for wind. The first auction for large-scale projects in Croatia took place in 2022 to procure 638 MW of new capacity. However, it only attracted tepid interest, with premiums awarded to just 107 MW of projects.

Will ie-energy accelerate the decarbonization of Croatia's energy sector?

In addition, it will accelerate the decarbonization of the Croatian energy sector, according to the announcement. IE-Energy is based in Rijeka, Croatia's fourth-largest city. It joined the intraday and day-ahead markets at the Croatian Power Exchange (CROPEX) last year. Documents reveal the project is scheduled to start on December 1.
