

What excise duties does Cyprus impose?

1. Introduction The Republic of Cyprus, being a Member State of the European Union imposes specific excise duties on alcoholic, tobacco and energy products. Consequently, Cyprus has adopted rules relating to the holding, intra - Community movement, and monitoring of these products.

How do I get a fuel exemption in Cyprus?

The exemption is granted upon application (ED23), to the Director of Customs. The production of an approval by the Cyprus Energy Regulatory Authority (R.A.E.K.) and a relevant guaranty are also needed. The approval of this exemption is subject to various terms and conditions. 7.2.1.4. Fuel for cement production

How do I get a tax warehouse license in Cyprus?

In order to obtain the above license, you must have the appropriate vessel, for which you have obtained an authorization from the Cyprus Ports Authority to use for bunkering purposes. The application shall be submitted through Form E.D.1 for the approval of the vessel as a tax warehouse.
