Can I ship a lithium battery to Japan?

We will not be able to shipabove mentioned items using Japan Post shipping methods (EMS,AIR,SAL and Surface Mail). Please be aware that if such type of lithium batteries arrived at our warehouse,it can only be discarded or ship to an address in Japan. (*If it is your first package,it can only be returned to the sender.)

Can I ship a lithium battery cross-border?

There are regulations attached to the cross-border shipping of batteries to ensure they travel safely. These regulations vary depending on the type of batteries. Lithium batteries, for example, are classified as Dangerous Goods, so not all types of lithium batteries are accepted by DHL Express which you can check here.

Can I ship lithium batteries to other countries?

Restrictions on shipping lithium batteries to certain countries and regions. We are able to ship these items via EMS,AIR,SAL,Surface mail to most countries and regions.
