# **Emission Permit Technical Specifications Battery**

How many emission permits are issued in China?

Since the 1980s,more than 20 provinces and municipalities in China have issued emission permits to more than 200,000enterprises. During this period, China's EPS has gone through 4 main stages. Table 1 presents the main events and important documents of this evolutionary process.

What is the implementation plan for controlling pollutant emission permit system?

The Implementation Plan for Controlling Pollutant Emission Permit System, which was issued in 2016, is a roadmap for the reform of the EPS. The Law on the Prevention and Control of Water Pollution, revised in 2017, further details the requirements and institutional arrangements for EP provision. Regulations for EP management have been promulgated.

What does an emission type approval authority do?

Approval authorities shall put in place measures to grant emission type-approvals to vehicle types, systems, components and separate technical units and to perform tests, checks and inspections for verifying whether the manufacturers comply with the requirements for conformity of production and in-service conformity in accordance with Annex V.

When will the Commission submit a report on battery durability?

4. By 31 December 2027,the Commission shall submit to the European Parliament and to the Council a report on battery durability reviewing the state of the art,as a basis for a review of the minimum performance requirements,with a view to the adoption of the delegated acts referred to in Article 15 (2),point (c).

What are the new regulations on batteries?

The new Regulation on batteries establish sustainability and safety requirements that batteries should comply with before being placed on the market. These rules are applicable to all batteries entering the EU market, independently of their origin.

Is the EPs a carrier of the emission declaration system?

At the beginning, the system orientation of the EPS as one of the country's eight environmental management systems was gradually established. However, the EP, for the first time connected to TEC, was like the carrier of the emission declaration system.
