## How to make a business declaration form for sending batteries

Do I need a lithium ion declaration?

NOTE: All shipments containing Section II lithium ion,or lithium metal batteries of any quantity or size,will require this declaration to be completed and submitted upon tender. Approved GPS and Temperature Trackers do not require this declaration. 2.

Do I need a shipper's declaration?

Shipper's Declaration is not required. The following statement must be mentioned on the (air)waybill: -"Lithium ion batteries in compliance with Section II of PI967". installed in equipment (including circuit boards). DHL Services: (TDI = Time Definite International ,ACS = Air Capacity Sales): TDI - Account must be approved. Service Code HV.

What is the pre-approval requirement for lithium battery shipments?

The pre-approval requirement applies to lithium metal battery shipments that are fully regulated and require dangerous goods shipping papers. Fully regulated shipments will also require a separate UPS Dangerous Goods Agreement. Read the International Air Transport Association guidance for lithium battery shipments

How should lithium batteries be packaged?

When preparing shipments containing lithium batteries, it is important to ensure the batteries are not in any way defective, damaged, or have the potential to produce a dangerous evolution of heat, fire or short circuit. When packaging lithium batteries for shipment, strong rigid outer packagingmust be used.

What are the packaging requirements for lithium ion batteries / cells?

ACS - No requirements. UN3481,Lithium Ion Batteries /Cells - PI967 Section II. The equipment must be packed in strong rigid outer packaging. Large equipment can be offered for transport unpackaged or on pallets when the cells or batteries are afforded equivalent protection by the equipment in which they are contained.

How do you package a battery?

Secure the battery to the equipment or within the packaging to prevent movement. Each battery must be individually packaged in inner packaging to prevent short circuits. Place batteries in a rigid outer packaging, ensuring they cannot move or come into contact with each other.

Note: The need for a battery declaration form may vary depending on specific regulations and requirements imposed by different countries, transportation authorities, or event organizers. It is advisable to check with the relevant ...
