# SOLAR PRO. Lifetime replacement warranty for new energy batteries

Will a pro rated battery be covered under a new limited warranty?

Effective upon purchase of a pro-rated replacement battery, this replacement battery will be covered under a new limited warranty. When a battery is replaced during the Pro-Rated Warranty period, the limited warranty renews effective on the date of the replacement battery date of purchase.

### What is the warranty length for a new battery?

The warranty for this battery consists of 18 months free replacement. Note: 825 Cold cranking Amps and 130 reserve minutes. Warranty consists of 2 years free replacement for the Yellow Top (Deep Cycle) battery. Height adapter may be required, check hood clearance. Battery is vented to the outside of the vehicle.

### Does the warranty cover givenergy battery storage?

In a nutshell, the warranty covers any GivEnergy residential battery storage system installed from 11/09/2023no matter which specific battery and inverter model are fitted. What does the DieHard battery warranty cover?

Are there any limitations associated with the DieHard battery warranty?

Yes, there are several limitations associated with the DieHard battery warranty: Non-transferable: The warranty applies only to the original purchaser and cannot be transferred. Proof of Purchase Required: Without a receipt, claims may be denied. Exclusions: Damage caused by misuse, neglect, or improper installation is typically not covered.

### How long will a battery pack last?

We guarantee that each battery pack will retain 70% use of its capacity for the less of either (i) 10MWh of energy throughput per 1kWh of usable capacity (which is equivalent to 5000 full cycles) at 90% DOD (excludes 8.2kWh and 9.5kWh batteries as they have unlimited throughput) (ii) a period of 10 yearsfrom initial installation date.
