How much is Octopus Energy generation worth?

These projects will add to Octopus Energy Generation's gargantuan portfolio, which consists of 3.7GW of combined generation capacity across various generation types, and is valued at around £6.7 billion.

Out of the roughly 2,000 U.S. Buick franchises that were open at the beginning of 2023, 47% or about 1,000 of them chose a buyout instead of investing hundreds of thousands of dollars in tooling, equipment, charging and training to prepare to sell and service EVs as the carmaker prepares to go all-electric by the end of the decade.

The buyout will enable Sensata (ST) to gain additional mileage within the fast growing end markets for clean energy solutions and offer a comprehensive bouquet of products for electrification.

In addition, Unifull said its Jiangsu Zhihang New Energy subsidiary is expected to apply Nissan's technology to its own automotive battery research and development. According to Unifull, GSR's Nissan battery business buyout fund is currently worth about \$1 billion and is expected to grow to \$1.25bn.
