# Tax on imported photovoltaic cells

What are the tax credits for solar photovoltaics?

The residential renewable energy tax creditcurrently provides a 30% tax credit for both corporations and residents who purchase and install solar photovoltaicson their businesses or homes in the United States.

Is photovoltaic import a matter of adding or taking away?

On photovoltaic import,in fact,it is not a matter of adding,but rather of taking away. Gecex-Camex has decided to put an end to the reduction of the import tariffs of the assembled modules,since there is an internal production in the country,revoking also a series of fiscal subsidies on the import.

Will solar panels be taxed abroad?

Therefore, the purchase of solar panels from abroad will again be subject to the 10.8% tax from next year, while the withdrawal of incentives will be effective in about 2 months.
