Do I need a prior approval for a solar panel installation?

Application to determine if prior approval is required for a proposed: These provide more scope for solar panel installations on buildings (or in the curtilage of a building) and in non-domestic off-street parking areas without needing full or householder planning permission. Do you need planning permission to install solar panels?

Current rules that require businesses to apply for planning permissionif solar panels will generate more than one megawatt of electricity will also be scrapped, meaning organisations will be able to install more solar panels on rooftops without the delay and cost of applying for planning permission.

Do you need permission to install a ground-mounted solar panel?

However, if you're a leaseholder, you'll need to obtain permission from your landlord or building management company before proceeding. Ground-mounted solar panels, also known as standalone systems, are subject to more stringent planning requirements.

How long does it take to get a solar connection?

Installers of solar PV, wind generation or battery storage are required to notify their Independent Distribution Network Operator (IDNO), to apply for a connection. The IDNO will normally respond within 65 days, provided all required data have been submitted.

Do I need an installer to install solar panels?

For domestic and small commercial properties, you will need to contact a solar panel installer to arrange installation of your panels. We're unable to recommend an installer. Once the panels have been installed, the installer will submit the relevant notification forms. Can I add capacity to an existing supply?

Can you put solar panels on your home?

This is due to "permitted development rights." These rights let you put up solar panels on your home if you follow certain rules. For roof or wall panels, they shouldn't stick out more than 200mm from the surface, and they can't be higher than the roof's top (not counting the chimney).
